## ASSIGNMENT

THIS ASSIGNMENT (the "Assignment"), made and entered into as of January \_\_, 2017 (the "Effective Date") is by and between Ronnie Wilson, a United States citizen, having a business address at 2727 Treble Creek, Apt. #122, San Antonio, Texas 78258 and Charlie Wilson, a United States citizen, having a business address c/o Pacific Coast Pirate Entertainment, 11511 Vimy Road, Granada Hills, California 91344.

WHEREAS, on June 19, 2015, Ronnie Wilson filed an application with the US Patent and Trademark Office seeking registration of the mark THE GAP BAND covering "audio, video and digital recordings featuring music and artistic performances of a band; compact discs featuring music" in International Class 9, said application subsequently issued as US Registration No. 5098276 on December 13, 2016.

WHEREAS, on July 6, 2015, Ronnie Wilson filed an application with the US Patent and Trademark Office seeking registration of the mark GAP BAND covering "clothing, namely, hats, t-shirts, and sweatshirts for sale at live music performances, live music concerts, live music shows and personal appearances" in International Class 25 and "entertainment services in the nature of live performances, live music concerts, and personal appearances all by a musical group; entertainment services in the nature of audio and visual performances by a musical group; audio and video recording services; entertainment, namely, production of live theatrical shows, live musical shows, concerts, and videos" in International Class 41 (Application Serial No. 86683774).

WHEREAS, Charlie Wilson has filed an opposition proceeding against the GAP BAND application captioned *Charlie Wilson v. Ronnie J. Wilson, Opposition No. 91230878*.

WHEREAS, the parties desire that Ronnie Wilson shall transfer and assign to Charlie Wilson and Charlie Wilson shall accept the GAP BAND and THE GAP BAND marks, US Registration No. 5098276 and Application Serial No. 86683774 (hereinafter collectively referred to as the "Assigned Marks") on the terms and conditions hereinafter set forth.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Ronnie Wilson and Charlie Wilson agree as follows:

1. Ronnie Wilson does hereby convey, transfer, assign and deliver to Charlie Wilson, free and clear of all Liens, an undivided FIFTY PERCENT (50%) right, title and interest in and to the Assigned Marks, including the registration and application for registration thereof, together with all the goodwill of the business connected with the use thereof and symbolized thereby.

2. Ronnie Wilson shall execute and deliver, without consideration, such documents as Charlie Wilson may reasonably request, and take any and all other actions necessary, proper or advisable to more effectively convey, transfer and record the 50% assignment of the Assigned Marks to Charlie Wilson, as contemplated by this Assignment.


3. Ronnie Wilson hereby authorizes and requests that the United States Patent and Trademark Office record this Assignment.
