**FIRST:** That Article 1 of the Amended and Restated Certificate of Incorporation be, and it hereby is, amended to read as follows:

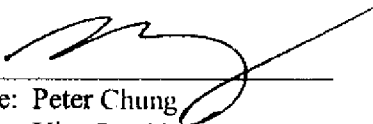
“The name of the corporation is “Fidelis Cybersecurity, Inc.”
