First Lien Trademark Security Agreement

THIS FIRST LIEN TRADEMARK SECURITY AGREEMENT, dated as of March 16, 2017 (this "**First Lien Trademark Security Agreement**"), is made by STERLING PAYMENT TECHNOLOGIES, LLC, a Florida limited liability company (the "**Grantor**"), in favor of SUNTRUST BANK, as administrative agent (in such capacity, together with its successors and permitted assigns, the "**Administrative Agent**") for the Secured Parties (as defined in the First Lien Security Agreement referred to below).

WHEREAS, EVO PAYMENTS INTERNATIONAL, LLC, a Delaware limited liability company (the "**Borrower**"), the Grantor, the lenders from time to time parties thereto (the "**Lenders**"), the issuing bank party thereto and the Administrative Agent have entered into a First Lien Credit Agreement, dated as of December 22, 2016 (as amended, restated, supplemented, replaced, increased, refinanced or otherwise modified from time to time, the "**First Lien Credit Agreement**");

WHEREAS, in connection with the First Lien Credit Agreement, the Borrower and certain of its Subsidiaries, including the Grantor, have entered into the First Lien Security Agreement, dated as of December 22, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "**First Lien Security Agreement**"), in favor of the Administrative Agent for the benefit of the Secured Parties; and

WHEREAS, the First Lien Security Agreement requires the Grantor to execute and deliver this First Lien Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and in order to ensure compliance with the First Lien Credit Agreement, the Grantor hereby agrees as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition are used as defined in the First Lien Security Agreement.

SECTION 2. Grant of Security Interest in Trademark Collateral. The Grantor, as collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Secured Obligations of the Grantor, hereby mortgages, pledges and hypothecates to the Administrative Agent for the benefit of the Secured Parties, and grants to the Administrative Agent for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under the following Collateral (the "**Trademark Collateral**"):

(i) all of its Trademarks, including, without limitation, the U.S. trademark registrations and applications referred to on Schedule 1 hereto;

(ii) all renewals and extensions of the foregoing;

(iii) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(iv) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

Notwithstanding the foregoing, no Lien or security interest is hereby granted on any Excluded Property, and, to the extent that any Collateral later becomes Excluded Property, the Lien granted hereunder will automatically be deemed to have been released; provided, further, that if and when any property shall cease

to be Excluded Property, a Lien on and security interest in such property shall automatically be deemed granted therein.

SECTION 3. Security Agreement. The security interest granted pursuant to this First Lien Trademark Security Agreement is granted in conjunction with the security interest granted to the Administrative Agent pursuant to the First Lien Security Agreement, and the Grantor hereby acknowledges and agrees that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the First Lien Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.


SECTION 4. Grantor Remains Liable. The Grantor hereby agrees that, anything herein to the contrary notwithstanding, the Grantor shall assume full and complete responsibility for the prosecution, defense, enforcement or any other necessary or desirable actions in connection with its Trademarks subject to a security interest hereunder.

SECTION 5. Counterparts. This First Lien Trademark Security Agreement may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Signature pages may be detached from multiple separate counterparts and attached to a single counterpart.

SECTION 6. Governing Law. This First Lien Trademark Security Agreement and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.

IN WITNESS WHEREOF, the Grantor has caused this First Lien Trademark Security Agreement to be executed and delivered by its duly authorized officer as of the date first set forth above.
