Further, Assignor represents that Assignor originally formed as a Texas limited liability company and secured the original registration of the one (1) registered trademark with the U.S. Trademark Office when Assignor was a limited liability company. Assignor also represents that it has filed the appropriate assignment related filing/document with the U.S. Trademark Office to reflect its conversion from a Texas limited liability company into a Texas corporation (which conversion occurred on or about December 28, 2009), in order that the registered owner of the one (1) registered trademark, as designated on Schedule A, reflect ownership in the name of Assignor with the U.S. Trademark Office.




