RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated February 7, 2017 by BANK OF MONTREAL, as Agent (“*BMO*”), with its mailing address at 115 South LaSalle Street, Chicago, Illinois 60603, acting as administrative agent hereunder for each Secured Party as defined in the Agreement referred to below (BMO acting as such administrative agent being hereinafter referred to as the “*Agent*”);

WITNESSETH:

WHEREAS, Liaison International LLC, a Delaware limited liability company (“*Debtor*”) with its principal place of business and mailing address at 311 Arsenal Street, Watertown, Massachusetts 02472, Academic Software Plus, LLC (“*Academic*”) and Agent were parties to a certain Trademark Security Agreement dated July 26, 2012 among Debtor, Academic and Agent which was recorded in the United States Patent and Trademark Office on July 27, 2012 at Reel 004830, Frame 0604 (the “*Agreement*”), pursuant to which Debtor granted to Agent for the benefit of the Secured Party, a continuing security interest in, among other things, trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the “*Trademark Property*”); and

WHEREAS, Debtor has requested that Agent release its security interests in the Trademark Property and reassign the same to Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:


Agent hereby releases its security interests in, and hereby reassigns, grants and conveys to Debtor, without any representation, warranty, recourse or undertaking by Agent, all of its right, title and interest, if any, in and to each trademark registration, and trademark application listed on Schedule A hereto, together with:

(i) All of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application; and

(ii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration, or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages.
