**RELEASE OF TRADEMARK SECURITY INTEREST**

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this "*Release*") is made effective as of March 9, 2017 (the "*Effective Date*"), by and from KEYBANK NATIONAL ASSOCIATION, with offices at 1675 Broadway #300 Denver CO 80202 (the "*Secured Party*"), to BINSWANGER ENTERPRISES, LLC, with offices at 965 Ridge Lake Blvd. #305 Memphis TN 38120 ("*Binswanger*").

WHEREAS, the Secured Party and Binswanger are parties to that certain Credit and Security Agreement dated March 16, 2016 (the "*Credit Agreement*"), pursuant to which Binswanger granted the Secured Party a security interest in the U.S. trademark reg. no. 4,648,484 for "BINSWANGER GLASS" (the "*Trademark*");

WHEREAS, such security interest has been recorded in the United States Patent and Trademark Office at Reel 5753, Frame 0445;

WHEREAS, all amounts owing and due under the Credit Agreement have been paid in full, and the Secured Party wishes to evidence the release of its interest in the Trademark, and retransfer and reassign to Binswanger, without recourse, all of its right, title and interest in and to the Trademark.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Release of Security Interest. The Secured Party hereby releases, terminates, cancels, relinquishes and discharges any security interest it may have in, and any right of set off against, the Trademark, including any goodwill of the business symbolized by the foregoing, and all rights to sue for past, present, and future infringements thereof, and retransfers and reassigns any and all right, title and interest it may have in and to the foregoing to Binswanger without recourse.
