RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release"), dated as of March 2, 2017, is made by Wells Fargo Bank, National Association ("Secured Party").



NOW THEREFORE, Secured Party hereby absolutely, unconditionally, and irrevocably releases, terminates and discharges the Trademark Agreement and Secured Party's security interest in, lien on, and conditional assignment of the Subject Trademarks and Secured Party hereby reassigns to Grantor any and all such right, title and interest (if any) that the Secured Party may have in the Subject Trademarks. Secured Party hereby authorizes the recordation of this Release with the USPTO. Secured Party agrees to cooperate with the Grantor and to provide the Grantor with the information and additional authorization reasonably required or desirable to effect the release of the Secured Party's security interest in the Subject Trademarks and the termination of the Trademark Agreement. This Release shall be governed by and construed in accordance with the laws of the State of New York.
