TERMINATION OF SECURITY INTEREST IN TRADEMARK

WHEREAS, RMA of New Jersey, L.L.C., a New Jersey limited liability company having a principal place of business at 140 Allen Road, Basking Ridge, New Jersey 07920 (the "Grantor"), is the owner of record of the trademark IVF NEW JERSEY FERTILITY CENTER "MAKING LITTLE MIRACLES COME TRUE" SINCE 1990 [stylized design and word mark] and the registration therefor, U.S. Registration No. 3435082 (Serial No. 77282601) issued by the United States Patent and Trademark Office (the "USPTO") on or about May 27, 2008, together with the goodwill of the business symbolized by the trademark and the Registration of the trademark (collectively, the trademark the subject of U.S. Registration No. 3435082, the Registration thereof and the goodwill of the business symbolized by the trademark and the Registration, the "Trademark");

WHEREAS, Grantor entered into a Trademark Security Agreement and Special Power of Attorney dated April 6, 2015 as to the Trademark (the "Security Agreement"), between Grantor and Citibank, N.A. with a principal address of 99 Wood Avenue South, 2nd Floor, Iselin, New Jersey 08830 (the "Secured Party"), a true and correct copy of which was recorded by the USPTO on April 17, 2015 at REEL 005499, FRAMES 0660-0670; and

WHEREAS, the Secured Party desires to release its security interest in and to the Trademark, terminate the Security Agreement, and discharge the security interest and the Security Agreement as and against the Trademark and Grantor.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Secured Party hereby:

1. Releases, discharges and reassigns to the Grantor any and all liens, security interests, right, title and interest of the Secured Party pursuant to the Security Agreement in the Trademark without recourse or representation or warranty, express or implied; and
2. Authorizes and requests the Commissioner of Trademarks of the USPTO to note and record the existence of the release and discharge hereby given.
