TERMINATION OF SECURITY INTEREST IN TRADEMARKS

March 16, 2017

WHEREAS, JANUS INTERNATIONAL GROUP, LLC, a Delaware limited liability company, having an office at 135 Janus International Boulevard, Temple, Georgia 30179 (the “Grantor”) has granted to FIFTH THIRD BANK, an Ohio banking corporation, having an office at 38 Fountain Square Plaza, Cincinnati, Ohio 45263, in its capacity as administrative agent for certain secured parties, as pledgee, assignee and secured party under the Agreement referenced below (in such capacities, the “Grantee”), a continuing security interest (the “Security Interest”) in (i) the Grantor’s right, title and interest in, to and under the trademarks, service marks, trademark registrations and service mark registrations set forth on Exhibit A attached hereto (the “Marks”), (ii) all proceeds and products of the Marks, (iii) the goodwill of the business with which the Marks are associated, and (iv) all causes of action arising prior to or after the date of the Agreement for infringement of any of the Marks or unfair competition regarding the same (the foregoing, collectively, the “Collateral”), pursuant to, among other things, a certain Grant of Security Interest in Trademarks, dated as of December 11, 2013 (as amended, amended and restated, supplemented or otherwise modified and in effect from time to time, the “Agreement”), which was filed at the United States Patent and Trademark Office on December 12, 2013 and recorded on Reel 5174, Frame 0108; and

WHEREAS, the Grantee has agreed to terminate the Security Interest.

NOW, THEREFORE, the Grantee hereby releases, discharges, waives and relinquishes all its rights, powers, privileges and remedies with respect to the Security Interest, and reassigns to the Grantor any and all interest in the Collateral, including, without limitation, the Marks set forth on Exhibit A attached hereto, and the goodwill of the business with which the Marks are associated. The Grantee agrees that, upon request of the Grantor or any successor-in-interest or assignee thereof, and at the Grantor’s sole cost and expense, the Grantee will execute any document, cause to be made any filing or take any other action deemed reasonably necessary or advisable by the Grantor, or any successor-in-interest or assignee thereof, to effectuate the release of interests contemplated herein.
