

6. The existing membership interests of Evermark LLC shall be converted into the same type and amount of membership interests that were outstanding prior to the conversion.

ARTICLES OF ORGANIZATION

OF

EVERMARK LLC

Article 1. Name. The name of the Limited Liability Company is **Evermark LLC** (hereinafter the "Company"). The Company is organized under the Georgia Limited Liability Company Act, O.C.G.A. Section 14-11-100 et seq.

Article 2. Registered Office and Agent. The initial registered office of the Company shall be at 1201 Peachtree Street, N.E., Atlanta, Fulton County, Georgia 30361, and the initial registered agent at such address shall be C T Corporation System.

Article 3. Principal Place of Business. The Company's initial principal place of business shall be located at 1050 Northbrook Parkway, Suwanee, Gwinnett County, Georgia 30024.

Article 4. Indemnification. No member or manager shall have any personal liability to the Company for monetary damages for breach of duty or care or other duty as a member or manager and the Company shall indemnify the members, managers, and agents of the Company from and against any and all claims and demands whatsoever arising in connection with the Company except that such persons shall be liable for and may not be indemnified for (a) intentional misconduct or a knowing violation of law; or (b) any transaction for which the person received a personal benefit in violation or breach of any provision of the operating agreement agreed to by the members of the Company; or (c) as otherwise limited by the Georgia Limited Liability Company Act.

Article 5. Management.

5.1. Unless otherwise provided for in a written operating agreement, management of the business and affairs of the Company shall be vested in the managers, and, subject to the provisions of a written operating agreement, the managers shall have the sole right and authority to manage the affairs of the Company and to make all decisions with respect thereto.


5.2. Unless otherwise provided in a written operating agreement, managers:

- (a) Need not be members of the Company or natural persons; and
- (b) Unless they have been earlier removed or have earlier resigned, shall hold office until their successors shall have been elected and qualified.
