RELEASE OF TRADEMARK SECURITY INTEREST

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of December 16, 2013, (hereinafter "Trademark Security Agreement"), TOUCH, LLC (hereinafter "Grantor") granted to LEVINE LEICHTMAN CAPITAL PARTNERS III, L.P. ("LEVINE") as Collateral Agent (hereinafter "Secured Party"), a security interest in all right, title or interest in or to any and all of the following assets and properties (collectively, the "Trademark Collateral"):

(a) each Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark;

(b) any and all licenses with respect to the Trademarks, including, without limitation, each of the licenses listed on Schedule 1(b) hereto; and

(c) all products and proceeds of the foregoing, including, without limitation, any claim by such Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or (ii) injury to the goodwill associated with any Trademark.

WHEREAS, LEVINE acknowledges and agrees that all of Grantor's obligations with respect to the Trademark Security Agreement have now been fully and completely satisfied and that the security interest granted has been and hereby is re-assigned, released, disclaimed, relinquished, discharged, and terminated in full;


WHEREAS, LEVINE desires to fully, completely and formally release the security interest in and to the Trademark Collateral, the Trademarks, and any other intellectual property of Grantor, and to record such release with the United States Patent and Trademark Office; and

WHEREAS, Grantor has requested and LEVINE has agreed to provide a document suitable for same.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, LEVINE, as Secured Party in the Trademark Security Agreement and on behalf of any lenders, does hereby fully, completely and formally re-assign, release, disclaim, relinquish, discharge, and terminate the security interest and any other interest it may have in, to, or under the Trademark Collateral, the Trademarks, and any other intellectual property of Grantor, effective as of March 14, 2017.
