

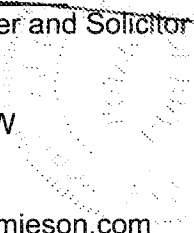

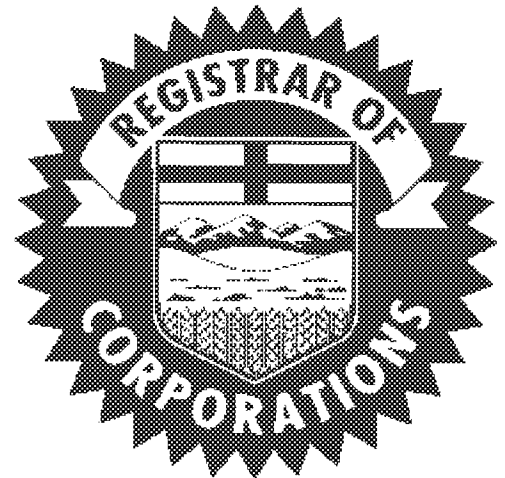

SCHEDULE "A"

The Corporation is authorized to issue an unlimited number of common shares and the common shares shall carry and be subject to the following rights, privileges, restrictions and conditions, that is to say:

Dividends

1. The holders of the common shares shall be entitled to dividends in such amounts and at such times as the directors shall from time to time determine.

2. Cheques of the Corporation payable at par at any branch of the Corporation's bankers in Canada shall be issued in respect of such dividends (less any taxes required to be deducted) and the mailing of such a cheque to any holder shall satisfy the dividend represented thereby.

Voting Rights

The registered holders of the common shares are entitled to one vote for each share held at all meetings of shareholders.

Liquidation

1. In the event of the liquidation, dissolution or winding-up of the Corporation, whether voluntary or involuntary:

A. The holders of the common shares shall be entitled to receive the remaining property of the Corporation.

SCHEDULE "B"

No shares of the capital stock of the Corporation shall be transferred without the consent of the board of directors of the Corporation, evidenced by a resolution passed by the board of directors of the Corporation.

SCHEDULE "C"

The holders of shares of a class or of a series shall not be entitled to vote separately as a class or series under section 176 of the Business Corporations Act (Alberta) but shall be entitled to vote with the holders of all other voting shares upon a proposal to amend the articles to:

a) Increase or decrease any maximum number of authorized shares of such class or increase any maximum number of authorized shares of a class having rights or privileges equal or superior to the shares of such class;

b) Effect an exchange, reclassification or cancellation of all or part of the shares or such class; or

c) Create a new class of shares equal or superior to the shares of such class.

2. The number of shareholders of the Corporation shall be limited to fifty (50), not including persons who are in the employment of the Corporation or of a subsidiary and persons who, having been formerly in the employment of the Corporation or of a subsidiary, were, while in that employment, and have continued after the termination of that employment to be, shareholders of the Corporation, two (2) or more persons holding one (1) or more shares jointly being counted as a single shareholder.

3. Any invitation to the public to subscribe for securities of the Corporation is prohibited.

4. The liability of each of the shareholders of the Corporation for any liability, act or default of the Corporation is unlimited in extent and joint and several in nature.

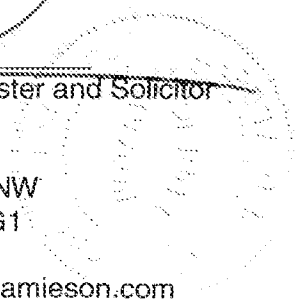

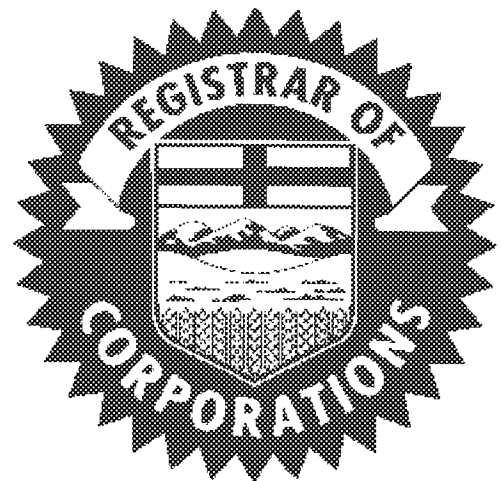

SCHEDULE B

(a) Without limiting the borrowing powers of the corporation as set forth in the Business Corporations Act (Alberta):

(i) The board of directors may from time to time in such amounts and on such terms as it deems expedient charge, mortgage, hypothecate or pledge all or any of the currently owned or subsequently acquired real or personal, movable or immovable, property of the corporation, including book debts, rights, powers, franchises and undertaking, to secure any debt obligations or any money borrowed, or other debt or liability of the corporation.

(ii) The board of directors may from time to time delegate to such one or more of the directors and officers of the corporation as may be designated by the board all or any of the powers conferred on the board above to such extent and in such manner as the board shall determine at the time of each such delegation.

(iii) The liability of each of the shareholders of the Corporation for any liability, act or default of the Corporation is unlimited in extent and joint and several in nature.

(b) Meetings of the shareholders of the Corporation may be held outside Alberta at either Toronto, Ontario or at Vancouver, British Columbia.
