RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (the “Release”), dated as of March 17, 2017, is made by BNP PARIBAS, as Administrative Agent for the Lenders (the “Secured Party”), pursuant to the Credit Agreement, dated as of April 1, 2016, (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”) and the Security Agreement, dated as of April 1, 2016, (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”).

WITNESSETH

WHEREAS, PAW ACQUISITION, LLC (the “Grantor”) is a party to the Security Agreement;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered to the Secured Party that certain Grant of Trademark Security Interest dated as of April 1, 2016 (the “Trademark Security Agreement”) and recorded with the United States Patent and Trademark Office on April 1, 2016 at Reel/Frame No. 5763/0959, pursuant to which the Grantor granted to the Secured Party a security interest in all of its right, title and interest in and to its Trademark Collateral (as defined in the Trademark Security Agreement);


WHEREAS, as of the date hereof, all of the obligations secured by the security interest granted under the Trademark Security Agreement have been paid, performed, satisfied and discharged in full and, in connection therewith, the Grantor has requested that the Secured Party release its security interest in all of its right, title and interest in and to the Trademark Collateral.



The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Secured Party may have obtained in, to and under the Trademark Collateral under the Trademark Security Agreement and the Security Agreement.
