## RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE is made as of June 3, 2010 by SUNTRUST BANK, as Administrative Agent for the Lenders ("*Secured Party*").

### WITNESSETH:

WHEREAS, Secured Party and UNITED FEATURE SYNDICATE, INC., a New York corporation ("*Grantor*"), were parties to that certain Grant of Security Interest Patents and Trademarks, dated August 5, 2009 (the "*2009 Security Agreement*") and that certain Grant of Security Interest Patents and Trademarks, dated January 20, 2010 (the "*2010 Security Agreement*"; together with the 2009 Security Agreement, the "*Security Agreements*"), and pursuant to the terms of the Security Agreements, Grantor granted a security interest to Secured Party in, among other things, the trademarks and all goodwill of the business connected with the use of and symbolized by the trademarks set forth in Exhibit A attached hereto (such trademarks and associated goodwill, the "*Released Trademarks*"); and

WHEREAS, in connection with the 2009 Security Agreement, Secured Party recorded a security interest in certain of the Released Trademarks with the Assignment Division of the United States Patent and Trademark Office on August 5, 2009 at Reel 004038, Frame 0344, and in connection with the 2010 Security Agreement, Secured Party recorded a security interest in certain of the Released Trademarks with the Assignment Division of the United States Patent and Trademark Office on January 21, 2010 at Reel 004138, Frame 0250.

NOW THEREFORE, in consideration for the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby releases its security interest in the Released Trademarks. Secured Party hereby retains its security interest in all Trademarks (as defined in the Security Agreements) and other assets that the Grantor granted to Secured Party pursuant to the Security Agreements that are not listed on Exhibit A.
2. Secured Party, to the extent granted in the Security Agreements, hereby assigns, grants and otherwise re-conveys to Grantor, without any representation, recourse or undertaking by Secured Party, all of its right, title and interest in and to the Released Trademarks and all goodwill associated therewith originally granted to Secured Party pursuant to the Security Agreements.
3. Upon the request of Grantor, Secured Party further agrees to execute all documents necessary to demonstrate and confirm the parties' intent under this Release of Trademark Security Interest.

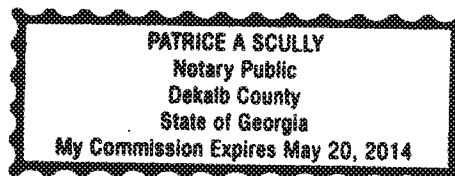
