This Proprietary Rights Assignment ("**Assignment**") is entered into as of the last date of the signatures below (the "**Effective Date**"), by and among **UNITED CONSUMERS CLUB, INC.**, an Indiana corporation, **DIRECTBUY, INC.**, an Indiana corporation, (each an "**Assignor**" and collectively, "**Assignors**") and **CSC GENERATION, INC.** a Delaware corporation ("**Assignee**").

WHEREAS Assignors and Assignee are parties to that certain Asset Purchase Agreement dated February 10, 2017 (the "**APA**"), by and among Assignors, Assignee and the other parties signatory thereto, pursuant to which Assignors and the other Sellers (as defined in the APA) are selling to Assignee certain assets of the Assignors and the other Sellers, and

WHEREAS, Assignors owns the all intellectual property and proprietary rights identified in Schedule 4.7(a) to the APA, including, without limitation, the following:

- (a) the trademarks identified in Annex A (collectively, the "**Trademarks**"), and
 - (b) the domains identified in Annex B (collectively, the "**Domains**"),
- (collectively, the "**Proprietary Rights**"); and

WHEREAS, Assignors wish to assign to Assignee any and all right, title and interest to the Proprietary Rights in accordance with the APA.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignors hereby assign to Assignee any and all right, title and interest which it has in and to the Proprietary Rights, together with the goodwill of that portion of the Assignor's business related to the Proprietary Rights, and the right to sue for past infringement thereof. The foregoing assignment of the Proprietary Rights includes all rights to sue and recover and retain damages, costs and attorneys' fees for past, present and future infringement and misappropriation and any other rights relating to any of the foregoing.

Assignors hereby agree to execute without further consideration any further documents and instruments which may be necessary, lawful and proper to secure to Assignee its interest and title in the aforementioned Proprietary Rights. Without limiting the foregoing, within ten (10) business days after the Closing Date (as defined in the APA), Assignors shall take all necessary steps to transfer the Domains into Assignee's name and control and to direct the Domain Name to server addresses as instructed by Assignee.

Assignors shall not challenge or assist any third party in challenging Assignee's ownership of the Proprietary Rights.

This Assignment shall be governed by and construed under the laws of the State of New York, except to the extent that such laws are superseded by the Bankruptcy Code. Bankruptcy Court or the Canadian Court, as applicable, shall have exclusive jurisdiction over any dispute between the parties arising out of or under this Assignment. Any process in any action, suit or proceeding arising out of or under this Assignment may, among other methods permitted by law, be served upon either party via courier delivery or First Class mail.

No amendment or modification of any provision of this Assignment shall be effective unless the same shall be in writing and signed by both parties.

This Assignment shall be interpreted in accordance with the terms and conditions of the APA.

This Assignment may be executed in several counterparts, each of which shall be deemed an original, but such counterparts shall together constitute but one and the same Assignment. The exchange of copies of this Assignment and of signature pages by facsimile or portable document format (.pdf) transmission shall constitute effective execution and delivery of this Assignment as to the parties and may be used in lieu of the original Assignment for all purposes. Signatures of the parties transmitted by facsimile or portable document format (.pdf) shall be deemed to be their original signatures for all purposes.

AMENDMENT NO. 1 TO PROPRIETARY RIGHTS ASSIGNMENT

THIS AMENDMENT NO. 1 TO PROPRIETARY RIGHTS ASSIGNMENT is dated as of March 21, 2017 (this "*Amendment*"), by and among UNITED CONSUMERS CLUB, INC., an Indiana corporation, DIRECTBUY, INC., an Indiana corporation, (each an "*Assignor*" and collectively, "*Assignors*") and CSC GENERATION, INC. a Delaware corporation ("*Assignee*").

RECITALS:

A. Assignors and Assignee entered into a Proprietary Rights Assignment dated as of February 21, 2017 (the "*Agreement*") and have agreed to amend the Agreement as provided herein.

NOW, THEREFORE, in consideration of the mutual representations, warranties, covenants and agreements contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and subject to the terms and conditions hereof, the parties, intending to be legally bound, hereby agree as follows:

ARTICLE I

DEFINITIONS

1.1 Capitalized terms not otherwise defined herein shall have the meanings set forth in the Agreement.

ARTICLE II

AMENDMENTS TO AGREEMENT

2.1 Amendments.

(a) Annex A to the Agreement shall be amended and restated in its entirety as Exhibit A attached hereto.

ARTICLE III

MISCELLANEOUS

3.1 This Amendment may be executed in any number of counterparts with facsimile signatures, each of which shall be an original, with the same effect as if the signatures thereto were on the same instrument, and such counterparts shall be construed together as one instrument.

3.2 The Bankruptcy Court shall retain jurisdiction over any and all disputes, controversies, claims or other matters arising under or otherwise relating to this Amendment.

3.3 Except as amended hereby, the Agreement shall remain in full force and effect without amendment or modification.

3.4 This Amendment shall be construed and interpreted, and the rights of the parties shall be determined, in accordance with the substantive laws of the State of New York, without giving effect to any conflicts of law.


