RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

This **RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST** (“**Release**”) is made effective as of December 13, 2016 (the “**Effective Date**”) and granted by Caisse de Dépôt et Placement du Québec (the “**Secured Party**”), in favor of Revision Military Inc. / Revision Militaire Inc. (“**Grantor**”) and its successors, assigns and legal representatives.

WHEREAS, Grantor granted a security interest to the Secured Party in all of Grantor’s right title and interest in and to certain of Grantor’s trademarks and trademark applications and patents and patent applications duly registered with the U.S. Patent and Trademark Office pursuant to that certain Universal Hypothec on Movable Property for Present and Future Obligations, dated April 23, 2013, by and between the Grantor and the Secured Party (the “**Security Agreement**”), recorded in the U.S. Patent and Trademark Office at Reel No. 031238, Frame 0333 on August 30, 2013 and at Reel No. 5127, Frame 0849 on August 30, 2013.

WHEREAS, the Grantor has requested that the Secured Parties enter into this Release in order to effectuate, evidence and record the release and reassignment to the Grantor of any and all right, title and interest the Secured Parties may have in the IP Collateral (as defined below) pursuant to the Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby states as follows:

1. **Release of Security Interest.** The Secured Party, individually and on behalf of its successors, legal representatives and assigns, hereby terminates the Security Agreement and terminates, releases and discharges any and all security interests that it has or may have pursuant to the Security Agreement in any and all right, title and interest of the Grantor, and reassigns to the Grantor any and all right, title and interest that it may have, in, to and under the following (collectively, the “**IP Collateral**”):

(a) any and all patents, patent applications and other patent rights and any other governmental authority-issued indicia of invention ownership, including the patents and patent applications listed in Schedule 1 hereto, and all reissues, divisions, continuations, continuations-in-part, renewals, extensions and reexaminations thereof and amendments thereto (the “**Patents**”);

(b) any and all trademarks, service marks, trade names, brand names, logos, trade dress, design rights and other similar designations of source, whether registered or unregistered, including the patents and patent applications listed in Schedule 2 hereto, together with the goodwill connected with the use thereof and symbolized thereby and all extensions and renewals thereof (“**Trademarks**”);

(c) any and all copyrights, copyright applications and registrations, and like protections in each work of authorship, whether registered or unregistered and whether published or unpublished and all extensions and renewals thereof (“**Copyrights**”);

(d) all rights of any kind whatsoever of such Grantor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;

(e) any and all license and other agreements in which such Grantor has granted or is granted a license or other right under any Patent, Trademark or Copyright;

(f) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(g) any and all claims and causes of action with respect to any of the foregoing, whether occurring before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

This Release may be executed in any number of counterparts (including by way of facsimile, Portable Document Format (PDF), or electronic transmission) and all of such counterparts taken together shall be deemed to constitute one and the same instrument.

This Release shall be governed by and interpreted and enforced in accordance with the laws of the Province of Quebec and the federal laws of Canada applicable therein.

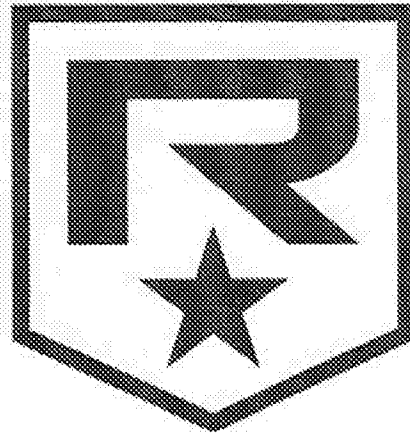
