**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (“**Termination and Release**”), dated as of March 21, 2017, is made by N. Williams Family Investments, L.P., an Indiana limited partnership (the “**Secured Party**”), in favor of National Lampoon, Inc., a Delaware corporation, National Lampoon Networks, Inc., a Delaware corporation, and National Lampoon Tours, Inc., a California corporation (collectively, the “**Grantors**”).

WITNESSETH:

WHEREAS, pursuant to that certain Security Agreement dated as of January 28, 2005 by and among the Secured Party and the Grantors (the “**Security Agreement**”), a security interest (the “**Security Interest**”) was granted by the Grantors to the Secured Party in the collateral specified in the Security Agreement, including the registered trademarks and service marks, applications for registration of trademarks and service marks, and licenses of registered trademarks and services marks specified in the Security Agreement, including those specified in **Exhibit A** hereto (collectively, the “**Trademark Collateral**”);

WHEREAS, the Trademark Assignment was recorded on February 2, 2005 in the United States Patent and Trademark Office under Reel 003020, Frame 0529;

WHEREAS, the Secured Party now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;


NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Secured Party hereby agrees as follows:

1. Release of Security Interest. The Secured Party hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Secured Party in such Trademark Collateral shall hereby cease and become void.
2. Further Assurances. The Secured Party hereby agrees to duly execute, acknowledge, procure and deliver any further documents and do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby, all at the sole cost and expense of the Grantors.
