and

Institutes of Business and Technology (UK) Pty Ltd ABN 27 087 590 010 of Level 8 Brookfield Place, 125 St Georges Terrace, Perth WA 6000, Australia (the **Assignee**).

RECITALS:

- (A) The Assignor is the owner of the Trade Marks and Trade Mark Registrations which are used in the Business.
- (B) The Assignor has entered into a Sale and Purchase Agreement with the Assignee with respect to the assets of the Assignor.
- (C) The Assignor agrees to assign its rights and interests in the Trade Marks and the Trade Mark Registrations, including the Goodwill, to the Assignee, on the terms set out in this document.

OPERATIVE PROVISIONS

1. INTERPRETATION

1.1 Definitions

The following definitions apply in this document.

Business means the business conducted by the Assignor at the date of this document.

Business Day means a day (other than a Saturday, Sunday or public holiday) on which banks are open for general banking business in Western Australia.

Completion means the completion of the Sale and Purchase Agreement.

Goodwill means the goodwill of the Business relating to the Trade Marks.

Register has the same meaning as in the *Trade Marks Act 1995* (Cth).

Sale and Purchase Agreement means the agreement of that name between the Assignor and the Assignee dated on or about the date of this document.

Tax means a tax, levy, duty, charge, deduction or withholding, however it is described, that is imposed by law or by a government agency, together with any related interest, penalty, fine or other charge.

Trade Marks means the trade marks that are the subject of the Trade Mark Registrations.

Trade Mark Registrations means the trade mark registrations set out in the Annexure.

1.2 Rules for interpreting this document

Headings are for convenience only, and do not affect Interpretation. The following rules also apply in interpreting this document, except where the context makes it clear that a rule is not intended to apply.

- (a) A reference to:
 - (i) a legislative provision or legislation (including subordinate legislation) is to that provision or legislation as amended, re-enacted or replaced, and includes any subordinate legislation issued under it;
 - (ii) a document (including this document) or agreement, or a provision of a document (including this document) or agreement, is to that document, agreement or provision as amended, supplemented, replaced or novated;
 - (iii) a party to this document or to any other document or agreement includes a successor in title, permitted substitute or a permitted assign of that party;
 - (iv) a person includes any type of entity or body of persons, whether or not it is incorporated or has a separate legal identity, and any executor, administrator or successor in law of the person; and
 - (v) anything (including a right, obligation or concept) includes each part of it.
- (b) A singular word includes the plural, and vice versa.
- (c) A word which suggests one gender includes the other genders.
- (d) If a word or phrase is defined, any other grammatical form of that word or phrase has a corresponding meaning.
- (e) If an example is given of anything (including a right, obligation or concept), such as by saying it includes something else, the example does not limit the scope of that thing.
- (f) The word **agreement** includes an undertaking or other binding arrangement or understanding, whether or not in writing.
- (g) The expression **this document** includes the agreement, arrangement, understanding or transaction recorded in this document.

2. ASSIGNMENT

The Assignor, as beneficial owner, assigns to the Assignee from Completion, absolutely, all rights and interests in:

- (a) the Trade Marks and the Trade Mark Registrations;

- (b) all intellectual property rights, including copyright, in the Trade Marks, throughout the world, for the remainder of the term of those rights, including all renewals and extensions; and
- (c) the right to sue for, and recover, damages and other relief in relation to any infringement of any of the rights assigned by this document (including for conversion or detention) including any that may have occurred before the date of this assignment.

This assignment includes the Goodwill.

3. **ASSIGNOR'S DELIVERY OBLIGATIONS**

The Assignor must, at its cost, ensure that all original certificates of registration and a copy of all other documents concerning the Trade Mark Registrations held by the Assignor or its solicitors, attorneys or agents are delivered to the Assignee or its nominee, within 7 days of the date of this document.

4. **NOTICES**

- (a) A notice, consent or other communication under this document is only effective if it is in writing, signed and either left at the addressee's address or sent to the addressee by mail or fax. If it is delivered, it is taken to have been received when it has been left at the addressee's address. If it is sent by mail, it is taken to have been received three Business Days after it is posted. If it is sent by fax, it is taken to have been received when the addressee actually receives it in full and in legible form.

5.1 **Amendment**

This document can only be amended or replaced by another document executed by the parties.

5.2 **Assignment**

Before Completion, a party may only assign, encumber, declare a trust over or otherwise deal with its rights under this document with the written consent of the other party.

6. **GENERAL**

6.1 **Governing law**

- (a) This document is governed by the laws of the State of Western Australia, Australia.
- (b) Each party submits to the jurisdiction of the courts of that State and of any court that may hear appeals from any of those courts, for any proceedings in connection with this document.

6.2 **Liability for expenses**

Subject to clause 6.3(a), each party must pay its own expenses incurred in negotiating, executing, stamping and registering this document.

6.3 **Giving effect to this document**

- (a) At the Assignee's cost, the Assignor must do anything (including execute any document), and must ensure that its employees and agents do anything (including execute any document), that the Assignee may reasonably require to give full effect to this document. These acts may include anything reasonably necessary to record the Assignee on the Register as the registered owner of the Trade Mark Registrations, and deposing to or swearing any declarations or oaths.
- (b) The Assignor irrevocably appoints the Assignee and each officer (as defined in the *Corporations Act 2001* (Cth)) of the Assignee, severally, as its attorney to do any of the acts referred to in clause 6.3(a).

6.4 **Waiver of rights**

A right may only be waived in writing, signed by the party giving the waiver, and:


- (a) no other conduct of a party (including a failure to exercise, or delay in exercising, the right) operates as a waiver of the right or otherwise prevents the exercise of the right;
- (b) a waiver of a right on one or more occasions does not operate as a waiver of that right or as an estoppel precluding enforcement of that right if it arises again; and

- (c) the exercise of a right does not prevent any further exercise of that right or of any other right.

6.5 **Operation of this document**

- (a) Subject to paragraph (b) this document contains the entire agreement between the parties about its subject matter. Any previous understanding, agreement, representation or warranty relating to that subject matter is replaced by this document and has no further effect.
- (b) Any right that a person may have under this document is in addition to, and does not replace or limit, any other right that the person may have.
- (c) Any provision of this document, which is unenforceable or partly unenforceable is, where possible, to be severed to the extent necessary to make this document enforceable, unless this would materially change the intended effect of this document.
