**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby expressly acknowledged, Assignor assigns to Assignee all right, title, and interest in and to the SPEEDKNIT Mark and the Registration, together with all of the goodwill relating thereto, and all rights of action and claims for past infringement thereof.
