THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of March 24, 2017 (this "**Release**"), is made by JPMorgan Chase Bank, N.A., as Administrative Agent for the Secured Parties (in such capacity, the "**Administrative Agent**"). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement, the Pledge and Security Agreement or the Trademark Security Agreement, as applicable, referred to below.

A. Reference is made to (i) that certain Credit Agreement dated as of March 17, 2015 (as amended as of October 25, 2016 and as further amended, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), among Surgical Care Affiliates, Inc., a Delaware corporation (the "**Borrower**"), each Lender and L/C Issuer from time to time party thereto, and the Administrative Agent, (ii) that certain Pledge and Security Agreement dated as of March 17, 2015 (as amended, supplemented or otherwise modified from time to time, the "**Pledge and Security Agreement**"), among the Borrower, certain Subsidiaries of the Borrower from time to time party thereto, and the Administrative Agent, and (iii) that certain Trademark Security Agreement (Short-Form) dated as of March 17, 2015 (as amended, supplemented or otherwise modified from time to time, the "**Trademark Security Agreement**"), among the Borrower, Surgical Care Affiliates, LLC, a Delaware limited liability company (the "**Grantor**"), and the Administrative Agent.

B. Pursuant to the Pledge and Security Agreement and the Trademark Security Agreement, the Grantor granted to the Administrative Agent, for the benefit of the Secured Parties, a security interest in all right, title and interest of the Grantor in, among other things, the Trademarks set forth on Schedule I hereto (the "**Trademark Collateral**"), which security interests were recorded with the United States Patent & Trademark Office on the date and at Reel/Frame set forth on Schedule I hereto.

C. Pursuant to the Payoff Letter dated as of March 24, 2017, among the Borrower and the Administrative Agent, the Administrative Agent agreed to release any and all interests it may have in the Trademark Collateral.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent does hereby release and discharge any and all security interests it has in the Trademark Collateral. This Release is made without representation or warranty by, or recourse to, the Administrative Agent or any other Secured Party. The Administrative Agent hereby agrees, at the Borrower's cost and expense, to duly execute and deliver any further documents and to do such other acts as may be reasonably requested and necessary to effectuate, or reflect of public record, the release and discharge of the security interests and liens contemplated hereby.

THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.
