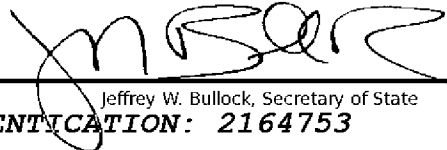

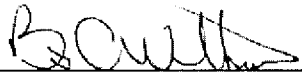
CERTIFICATE OF AMENDMENT OF CERTIFICATE OF FORMATION
