RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS (this "Release"), dated as of March 22, 2017 (the "Effective Date"), from Fortitude Capital, LLC, a Texas limited liability company, as agent (the "Secured Party") for itself and the other Subordinated Secured Lenders to Flexible Lifeline Systems, Inc., a Texas corporation (the "Grantor"). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement (as defined below).

WHEREAS, the Grantor entered into that certain Subordinated Security Agreement (as amended, modified, restated or supplemented from time to time, the "Security Agreement"), dated as of September 30, 2013, pursuant to which the Grantor granted to the Agent a security interest (the "Security Interest") in all of the Grantor's right, title and interest in and to the Intellectual Property, and the use thereof, including the patents (the "Patents") and trademarks (the "Trademarks") set forth on Schedule A hereto (collectively, the "Collateral");

WHEREAS, the Security Interest regarding Patents was recorded in the United States Patent and Trademark Office on October 8, 2013, at Reel 031423 and Frames 509 through 513;

WHEREAS, the Security Interest regarding Trademarks was recorded in the United States Patent and Trademark Office on October 8, 2013, at Reel 005131 and Frames 326 through 330; and

WHEREAS, the Agent now desires to terminate and release the entirety of its security interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby, without representation, warranty or recourse of any kind, terminates, discharges, cancels and releases any and all liens and security interests it has against the Collateral.

The Agent shall take all further actions (including, the execution and delivery of any and all documents or other instruments), reasonably necessary to effect the release of the liens and security interests contemplated hereby, and at Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

This Release shall be construed in accordance with and governed by the laws of the State of Texas.


