ASSIGNMENT OF FEDERAL TRADEMARK

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor hereby assigns to the Assignee all right, title and interest in and to the Mark, together with the goodwill of the business associated with and symbolized by the Mark, the Registrations, and the right to sue for past infringement, if any there may be, together with all the Assignor's interest in all coexistence agreements, consent agreements, licenses, restrictive covenants and other agreements relating to the Mark.
