## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), effective as of February 15, 2017 is made by **WELLS FARGO BANK, NATIONAL ASSOCIATION** ("Lender"), in favor of **MISSION PRODUCT HOLDINGS, INC.** ("Borrower"), pursuant to the Loan and Security Agreement, dated November 20, 2011, between Borrower and Lender (as amended, the "Loan Agreement").

1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Loan Agreement and Trademark Agreement, as applicable (it being understood that, unless otherwise provided, in the event of any conflict, such terms shall have the meanings provided or provided by reference in the Loan Agreement).

2. Release of Security Interest. Lender does hereby release and reassign to Borrower its security interest in, lien upon and conditional assignment of the Trademarks more fully identified in Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby, provided, that, in no event shall this Release be deemed to be a release of Lender's lien and interest in any Trademarks other the Trademarks identified on Schedule A annexed hereto.

3. Purpose. Lender does hereby authorize and request that the United States Patent and Trademark Office note and record the existence of the release hereby given.
