**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of March 29, 2017 (this "Release"), is made by **VELOCITY VENTURE FUNDING, LLC**, as security agent (in such capacity, the "Agent"), in favor of **VERACODE, INC.** ("Grantor"), as follows. Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Trademark Security Agreement (as defined below).

WITNESSETH

WHEREAS, pursuant to the Trademark Grant of Security Interest, dated as of February 1, 2009 (the "Trademark Security Agreement"), and recorded with the U.S. Patent and Trademark Office on February 4, 2009, at Reel/Frame No. 3929/0555, Grantor granted to the Agent a security interest in all of Grantor's right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement), including, without limitation, the United States trademarks set forth on Schedule A attached hereto (the "Released Registered Trademarks"); and

WHEREAS, the Secured Obligations (as defined in or by reference in the Security Agreement) have been discharged and the Grantor has requested that the Collateral Agent release its security interest in and continuing lien on all right, title and interest of Grantor in, to and under the Intellectual Property Collateral, including the Released Registered Trademarks; and

WHEREAS, the Collateral Agent now desires to terminate and release its security interest in and continuing lien on all right, title and interest of Grantor in, to and under the Intellectual Property Collateral, including the Released Registered Trademarks, and reassign any all rights, title and interest in the same to Grantor.


NOW, THEREFORE, the Collateral Agent, without recourse, representation or warranty of any kind or nature, and at Grantor's sole cost and expense, hereby terminates the Security Agreement and terminates, cancels and releases its security interest in and continuing lien on all right, title and interest of Grantor in, to and under the Intellectual Property Collateral, including the Released Registered Trademarks, and any right, title and interest of the Collateral Agent in such Intellectual Property Collateral and such Released Registered Trademarks, including all goodwill associated therewith, is hereby assigned, transferred, and conveyed to Grantor.

The Collateral Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.
