REASSIGNMENT AND RELEASE OF SECURITY INTEREST

This Reassignment and Release of Security Interest is made as of March 29, 2017 by COMERICA BANK ("Secured Party") in favor of OCEAN PULSE, a California corporation d/b/a Ocean Pro International and Aeris ("Debtor"), with its principal place of business at 2002 Davis Street, San Leandro, California 94577.
