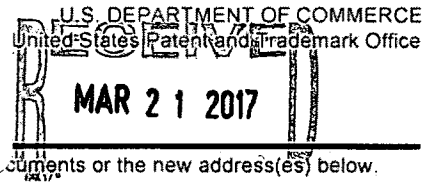






RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of February 27, 2017 ("Release"), is made by Regions Bank, as collateral agent for the Secured Parties (as defined below) ("Collateral Agent"), in favor of EarthLink, LLC, a Delaware limited liability company, Conversent Communications Resale, L.L.C., a Delaware limited liability company, CTC Communications Corp., a Massachusetts corporation, Deltacom, LLC, an Alabama limited liability company, EarthLink Business, LLC, a Delaware limited liability company, EarthLink Managed Services, LLC, a South Carolina limited liability company, ITC^Deltacom, Inc., a Delaware corporation, Lightship Telecom, LLC, a Delaware limited liability company, and US Xchange of Wisconsin, L.L.C., a Delaware limited liability company (each a "Grantor", and collectively, the "Grantors") and their successors, assigns and legal representatives.

WHEREAS, pursuant to that certain Second Amended and Restated Security and Pledge Agreement dated as of June 30, 2016 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement") by and among the Grantors, Collateral Agent, and others party thereto, Grantors granted to the Collateral Agent, for the benefit of the Secured Parties, a continuing security interest in, and a right to set off against, any and all right, title and interest of Grantors in and to Trademarks, Trademark Licenses, and Proceeds of the foregoing (collectively, "Trademark Collateral");

WHEREAS, pursuant to the Security Agreement, Grantors executed and delivered to Collateral Agent, for the benefit of the Secured Parties, the Notice of Grant of Security Interest in Trademarks recorded at the United States Patent and Trademark Office ("USPTO") on June 7, 2013 at Reel 5042 Frame 0369 ("Notice"); and

WHEREAS, Grantors have requested that Collateral Agent enter into this Release in order to effectuate, evidence and record the release to the Grantors of any and all right, title and interest the Collateral Agent and the Secured Parties may have in the Trademark Collateral pursuant to the Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby states as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

SECTION 2. Release. Collateral Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in and to, and the right to set off against, any and all right, title, and interest of Grantors in and to the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Notice; and

(b) authorizes the recordation of this Release with the USPTO at Grantors' expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, the Collateral Agent, on behalf of the Secured Parties, has caused this Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
