TERMINATION OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This **TERMINATION OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of March 30, 2017, is made by Monroe Capital Management Advisors, LLC, as administrative agent (the "Administrative Agent") under that certain Intellectual Property Security Agreement, dated as of September 14, 2015 between Saladworks, LLC, an Illinois limited liability company (the "Borrower") and the Administrative Agent (as amended, supplemented or modified and in effect from time to time, the "IP Security Agreement").

WHEREAS, pursuant to the IP Security Agreement the Borrower granted a security interest to the Administrative Agent in certain Intellectual Property collateral including the Trademarks set forth on Exhibit A thereto (the "IP Collateral"); and

WHEREAS, the IP Security Agreement was recorded with the Trademark Assignment Division of the United States Patent and Trademark Office on September 16, 2015 at Reel 5623, Frame 0980; and

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all of such Trademarks, including, without limitation, the Trademarks identified on Schedule A attached hereto, being the same Trademarks set forth on Exhibit A to the IP Security Agreement.


