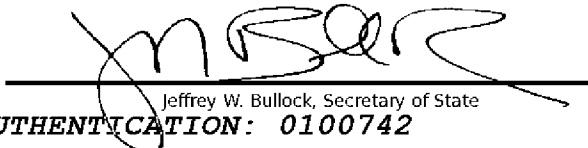

The undersigned, Daniel Schmidt, Secretary and Treasurer of HONEYWELL POMS CORP., does hereby certify:

1. The name of the corporation is HONEYWELL POMS CORP., a Delaware corporation (the "Corporation").
2. The Certificate of Incorporation of the Corporation was filed by the Department of State of the State of Delaware on June 6, 1997.
3. The Certificate of Incorporation of the Corporation is hereby amended to change the name of the Corporation from HONEYWELL POMS CORP. to POMS CORPORATION.

To effect such amendment:
