

The validity, construction and enforceability of this Agreement shall be governed in all respects by the law of the State of Florida. This Agreement may not be amended except in writing signed by a duly authorized representative of the respective parties. This Agreement shall control in the event of a conflict with any other agreement between Silversphere and Knockdown with respect to the subject matter hereof. The failure of either party to enforce its rights under this Agreement at any time for any period shall not be construed as a waiver of such rights.



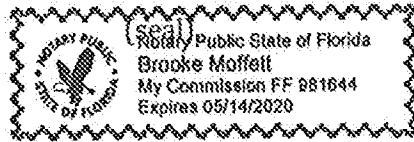
