**NOTICE OF NAME CHANGE WITH RESPECT TO GRANT OF SECURITY
INTEREST IN TRADEMARKS**

This NOTICE OF NAME CHANGE WITH RESPECT TO GRANT OF SECURITY INTEREST IN TRADEMARKS (this "Notice") dated as March 30, 2017, is filed by VISTA WINDOW COMPANY, LLC, a Delaware limited liability company, formerly known as VISTA ACQUISITION COMPANY LLC, a Delaware limited liability company ("Vista").

WHEREAS, TEXAS CAPITAL BANK, NATIONAL ASSOCIATION, a national banking association ("Lender"), recorded a Notice of Grant of Security Interests in Trademarks in the United States Patent and Trademark Office (the "PTO") on March 8, 2017 at Reel 6006 Frame 0321 (the "Original Notice") evidencing a security interest in favor of Lender in Vista's trademarks and service marks as set forth therein (collectively, the "Trademarks"); and

WHEREAS, effective as of March 7, 2017, Vista filed a Certificate of Amendment with the Secretary of State of the State of Delaware, a copy of which is attached as Schedule 1, changing its name from VISTA ACQUISITION COMPANY LLC, a Delaware limited liability company, to VISTA WINDOW COMPANY, LLC, a Delaware limited liability company.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, Vista hereby agrees as follows:

1. Vista has agreed to execute and deliver to Lender this Notice for purposes of filing the same with the PTO to verify, confirm and evidence Vista's name change from VISTA ACQUISITION COMPANY LLC, a Delaware limited liability company, to VISTA WINDOW COMPANY, LLC, a Delaware limited liability company.

2. This Notice constitutes public notice of the change in Vista's name, and Lender's valid, continuing security interest in, and lien on, Vista's right, title and interest in, to and under the Trademarks and all goodwill of any business connected with the use of and symbolized thereby.

3. Vista hereby requests the PTO to file and record the same together with the annexed Schedule 1.
