RELEASE AND REASSIGNMENT OF  
TRADEMARKS

March 31, 2017

Reference is hereby made to (i) that certain Trademark Security Agreement dated as of December 20, 2012, executed by PASSPORT FOOD GROUP, LLC, a California limited liability company ("Grantor"), successor by merger to GOLDEN PHEASANT FOODS, LLC, a California limited liability company ("Initial Grantor," and together with Grantor, "Grantors"), whose address is 2539 E. Philadelphia Street, Ontario, California 91761, in favor of CALIFORNIA UNITED BANK ("Lender"), whose address is 15821 Ventura Boulevard, Suite 100, Encino, California 91426, which was recorded in the United States Patent and Trademark Office ("USPTO") on December 26, 2012 at Reel 4929, Frame 0038 ("Initial Agreement"), (ii) that certain First Amendment to Trademark Security Agreement dated as of January 28, 2014 executed by Grantor in favor of Lender, which was recorded in the USPTO on January 29, 2014 at Reel 5203, Frame 0707 ("First Amendment"), and (iii) that certain Second Amendment to Trademark Security Agreement dated as of May 17, 2016, executed by Grantor, in favor of Lender, which was recorded in the USPTO on May 19, 2016 at Reel 5796, Frame 0840 (the "Second Amendment," and together with the Initial Agreement and First Amendment, "Agreements"), and pursuant to which the Grantors assigned and granted to Lender, a security interest in and to all of Grantors' right, title and interest in and to among others, certain trademarks, including those trademarks and trademark applications specifically listed on Exhibit A attached hereto; and

WHEREAS, Lender wishes to terminate the Agreements and release, retransfer and reassign to Grantor, without representation or warranty, all of Lender's right, title and interest in and to the Trademarks and the Licenses (each as defined below); and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Lender hereby terminates each Agreement, releases, retransfers and reassigns to Grantor, without representation or warranty, all of Lender's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired, and authorizes and requests that the USPTO note and record the existence of the release hereby given:

(a) all of Grantor's trademarks, trademark applications, service marks, trade names, mask works, and associated goodwill (collectively, "Trademarks"), and licenses for any of the foregoing ("Licenses"), including, but not limited to those Trademarks and Licenses referred to on Exhibit A hereto;

(b) all reissues, continuations, continuations-in-part, substitutes, extensions or renewals of and improvements on the foregoing; and

(c) all products and proceeds of the foregoing, including any claim by Grantor against third parties for past, present or future infringement or dilution of any Trademark or any Trademark licensed under any License.


