DECLARATION


This Declaration is made this 14<sup>th</sup> day of February, 2017 by Aptalis Pharma US, Inc., a Delaware corporation, having offices at Morris Corporate Center III, 400 Interpace Parkway, Parsippany, New Jersey ("Affiant").


WHEREAS on March 27, 2015, Affiant recorded with the US Trademark Office an Assignment of Trademarks purportedly transferring ownership in various trademarks (the "Trademarks") from Aptalis Pharmatech Inc. to Aptalis Pharma US, Inc. This Assignment was recorded at Reel: 005487, Frame: 0207. However, since Aptalis Pharmatech Inc. was not an owner of any of the Trademarks listed on the aforementioned assignment, it could not have transferred any interest in any of the Trademarks.
