**TERMINATION AND RELEASE  
OF GRANT OF SECURITY INTEREST (TRADEMARKS)**

**TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST (TRADEMARKS)** (“Release”), dated as of March 29, 2017, by **WEBSTER BUSINESS CREDIT CORPORATION**, as Lender (the “Lender”), in favor of **BACHMANN INDUSTRIES, INC.**, a Pennsylvania corporation (the “Grantor”).

**WHEREAS**, pursuant to the terms of that certain Security Agreement, dated as of March 18, 2015 (as amended supplement or otherwise modified from time to time, the “Security Agreement”), and that certain Grant of Security Interest (Trademarks) (the “Agreement”), dated as of March 18, 2015, between the Grantor and the Lender, the Grantor granted to the Lender a security interest in and to all of the right, title and interest of the Grantor in and to the trademarks listed on Schedule A attached hereto, which trademarks are registered in the United States Patent and Trademark Office (the “Trademarks”), together with the goodwill of the business symbolized by the Trademarks, and all proceeds thereof, including, without limitation, from any and all causes of action which may exist by reason of infringement thereof (together with the Trademarks, the “Collateral”), to secure the prompt payment, performance and observance of the Obligations (as defined in the Security Agreement referred to in the Agreement);

**WHEREAS**, the Lender wishes to terminate and release its security interests in and to all of the right, title and interest of the Grantor in and to the Collateral, including the Trademarks identified on Schedule A attached hereto; and

**WHEREAS**, the Agreement was filed on March 19, 2015 with the United States Patent and Trademark Office in Reel: 5482; Frame: 0018.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby terminates, releases and discharges fully its security interests in and to all of the right, title and interest of the Grantor in and to the Collateral, as granted under the Agreement and the Agreement, and reassigns and transfers to the Grantor all right, title and interest that the Lender may have in the Collateral, and terminates the Agreement. The Lender hereby authorizes the Grantor, or the Grantor’s authorized representative, to record this Release with the United States Patent and Trademark Office.
