**RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of March 29, 2017 (this "Release"), is made by PNC Bank, National Association, as administrative agent ("Administrative Agent") under that certain Credit Agreement dated June 14, 2011, by and among Administrative Agent, Arch Coal, Inc., a Delaware corporation ("Grantor"), and certain other parties thereto, in favor of Grantor, as follows:

WITNESSETH

WHEREAS, pursuant to the Acknowledgment of Security Interest in Trademarks (Borrower), dated as of June 14, 2011 and recorded with the U.S. Patent and Trademark Office on June 14, 2011 at Reel/Frame No. 4561/0146 (the "Acknowledgment"), the Grantor granted to Administrative Agent a security interest in certain collateral pledged by the Grantor described therein (collectively, the "Trademarks"), including, without limitation, the United States trademarks and service marks set forth on Schedule A attached hereto;

WHEREAS, the Grantor has requested that Administrative Agent release its security interest in, and retransfer and reassign to the Grantor all right, title and interest of the Administrative Agent in and to, the Trademarks.

NOW, THEREFORE, Administrative Agent, without recourse, representation or warranty and at the Grantor's sole cost and expense, hereby (a) terminates, cancels and releases the security interest in the Trademarks, (b) retransfers and reassigns to the Grantor any right, title and interest of Administrative Agent in and to the Trademarks, and (c) terminates the Acknowledgment, except for any provisions therein that expressly survive such termination.

Administrative Agent agrees to provide the Grantor with any information and additional authorization and documentation necessary to effect the release of Administrative Agent's security interest in the Trademarks (without recourse, representation or warranty and at Grantor's sole cost and expense).

All capitalized terms, used but not expressly defined in this Release have the meanings given to them in the Acknowledgement.


