RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”) is made this 3rd day of April, 2017, by SCOTT VALLEY BANK, as lender (in such capacity, the “Lender”).

WHEREAS, reference is made to the (i) Commercial Security Agreement dated as of December 19, 2011 and recorded with the United States Trademark and Trademark Office on January 5, 2012, at **Reel 004693 Frame 0324** (recorded as Scott Valley Bank as Assignee) (as may be amended, restated, amended and restated, supplemented and/or modified to date, the “IP Security Agreement”), by GIMBAL BROTHERS, INC. (the “Grantor”), in favor of Lender. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Commercial Security Agreement.

WHEREAS, under the IP Security Agreement, Grantors granted to Lender, a continuing security interest in all of the right, title and interest of Grantors in and to the Collateral (as defined in the IP Security Agreement) identified therein, including, but not limited to, the Trademarks set forth on the Schedules attached hereto.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby (i) terminates the IP Security Agreement, (ii) releases any and all liens on, and its security interest in and to the Collateral arising under the IP Security Agreement, including, but not limited to, the Trademarks set forth on the schedules attached hereto, and (iii) authorizes the recordation of this Release by Grantors or its designee with the United States Patent and Trademark Office.

This Release shall be governed by and construed in accordance with the laws of the State of New York without regard to conflicts of law principles.
