TRADEMARK RELEASE

TRADEMARK RELEASE, effective as of this 3rd day of April, 2017, given by Bank of America, N.A., as Collateral Agent, (the "Collateral Agent") with principal offices at 1 Bryant Park, New York, New York 10036, to BWAY Corporation, a Delaware corporation, North America Packaging Corporation, a Delaware corporation, and Ropak Corporation, a Delaware corporation, (collectively, the "Grantors" and each a "Grantor") with principal offices at c/o BWAY Corporation, 8607 Roberts Drive, Suite 250, Atlanta, GA 30350-2237, as follows:

W I T N E S S E T H

WHEREAS, the Grantors have heretofore granted to the Collateral Agent a security interest in certain U.S. trademarks, trademark registrations and trademark applications, including but not limited to those United States trademarks, trademark registrations and trademark applications more particularly set forth on Schedule A attached hereto (the "Trademarks") to secure the Obligations (as defined in that certain Security Agreement, dated as of August 14, 2014 as amended, amended and restated, supplemented or otherwise modified from time to time, including by that certain Joinder Agreement, dated as of December 7, 2016, the "Security Agreement"), between the Collateral Agent, the Grantors, and the other guarantors party thereto), which security interest was recorded August 15, 2014 at the United States Patent and Trademark Office at Reel 5344, Frame 0945; and
