RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY (this "Release"), dated as of February 13, 2017, is executed by ACF FINCO I LP, a Delaware limited partnership, as assignee of FCC, LLC, d/b/a First Capital Western Region, LLC ("Lender"), in favor of Pierre Andre Senizergues, an individual ("Grantor"). All capitalized terms used in this Release and not otherwise defined herein, shall have the respective meanings given to such terms in the Intellectual Property Security Agreement (as defined below).

RECITALS

A. WHEREAS, the Grantor has, pursuant to that certain Intellectual Property Security Agreement dated December 18, 2012, recorded in the United States Patent and Trademark Office (the "USPTO") on December 28, 2012 at Reel 4928, Frame 0053 (as the same may be amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date hereof, the "Intellectual Property Security Agreement") granted to Lender a security interest in and to all of each Grantor's right, title and interest in and to the Intellectual Property Collateral, including without limitation those trademarks listed on Exhibit A attached hereto (collectively, the "Released Collateral"); and

B. WHEREAS, Lender wishes to terminate and release, without representation or warranty, its security interest in and to the Released Collateral as provided in this release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Lender hereby terminates and releases, without representation or warranty, its security interest in and to the Released Collateral and terminates the Intellectual Property Security Agreement. Lender acknowledges that this Release may be filed with the USPTO or any other governmental office to evidence the release granted herein at the sole expense of the Grantor. The Lender authorizes the Grantor to record this Release with the USPTO and other applicable registry at the sole expense of the Grantor and agrees to provide the Grantor with any information and additional authorization necessary to effect the release of the security interest in the Released Collateral.
