## TRADEMARK RELEASE

TRADEMARK RELEASE, effective as of this 3rd day of April, 2017, given by Wilmington Trust, National Association, as Collateral Agent (the "Agent") with principal offices at 246 Goose Lane, Suite 105, Guilford, Connecticut 06437 to NES Rentals Holdings, Inc., a Delaware corporation (the "Grantor"), with principal offices at 540 Lake Cook Road, Suite 100, Deerfield, IL 60015, as follows:

### W I T N E S S E T H

WHEREAS, the Grantor has heretofore granted to the Agent a continuing security interest in (i) all of Grantor's right, title and interest in and to the United States trademarks, trademark registrations and trademark applications set forth on Schedule A attached hereto (the "Marks"), (ii) all Proceeds (as such term is defined in the Agreement) and products of the Marks (and only those Marks), (iii) the goodwill of the business with which the Marks (and only those Marks) are associated, (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks (and only those Marks) or unfair competition regarding the same (collectively, the "Collateral"), to secure the Secured Obligations of the Grantor, as such term is defined in the Second-Lien Security Agreement among the Grantor, the other parties from time to time party thereto and the Agent, dated as of April 17, 2013 (as amended, modified, restated and/or supplemented from time to time, the "Agreement"); and


WHEREAS, the Agent wishes to release its continuing security interest in the Collateral and restore all right, title and interest in and to the Collateral to the Grantor, and to dissolve any and all liens and encumbrances with respect to the Marks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby releases, discharges, quit claims and relinquishes unto the Grantor, without representation and warranty, the continuing security interest in the Collateral (including, but not limited to, the Marks) granted to the Agent by the Grantor pursuant to the Agreement, which security interest was duly recorded on April 19, 2013 at Reel 5010 / Frame 0470 in the United States Patent and Trademark Office.
