RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, pursuant to that certain U.S. Pledge and Security Agreement, dated as of January 26, 2007, by and among Citibank, N.A. as Agent, the Grantors and certain other parties thereto, as amended by that certain Amendment Agreement, dated as of March 26, 2010, by and among Citibank, N.A. as Retiring Agent and JPMorgan Chase Bank, N.A. as Agent and certain other parties thereto (as further amended, amended and restated, or otherwise modified from time to time, the "Security Agreement"), the Grantors granted to the Agent, in its capacity as Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, certain Grantors executed and delivered a Trademark Security Agreement, dated as of January 26, 2007, for recordal with the United States Patent and Trademark Office;

WHEREAS, the Security Agreement was amended by that certain Trademark Assignment and Assumption Agreement, dated as of March 26, 2010 by and among Citibank, N.A. as Assignor and JPMorgan Chase Bank, N.A. as Assignee (as further amended, amended and restated, or otherwise modified from time to time, the "Trademark Security Assignment and Assumption Agreement");,

WHEREAS, the Trademark Security Assignment and Assumption Agreement was recorded with the United States Patent and Trademark Office on and recorded May 10, 2010 at Reel/Frame 4201/0837;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Assignment and Assumption Security Agreement, as applicable.

2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Trademarks, including the trademark registrations and applications set forth Schedule B attached hereto, arising under the Security Agreement and the Trademark Security Assignment and Assumption Agreement. If and to the extent that the Agent has acquired any right, title or interest in and to the Trademarks under the Trademark Security Assignment and Assumption Agreement, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.


3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Assignment and Assumption Agreement.

4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantors and their respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release. The Agent hereby authorizes and requests that the Commissioner for Patents of the United States Patent and Trademark Office record this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the state of New York, without regard to conflicts of law or choice of law principles.
