SECOND SUPPLEMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Second Supplement to Intellectual Property Security Agreement (this “*Supplement*”) is made as of April 3, 2017 by and between **SILICON VALLEY BANK**, a California corporation (“*Bank*”) and **BLUEPRINT SOFTWARE SYSTEMS INC.**, a corporation organized under the laws of the Province of Ontario (the “*Grantor*”).

WHEREAS, Grantor executed and delivered an Intellectual Property Security Agreement dated November 18, 2010 and recorded with the Patent division of the United States Patent and Trademark Office on October 23, 2013 at Reel 031485, Frame 0017 (as amended, the “*IP Agreement*”) in favor of the Bank, pursuant to which the Grantor pledged, assigned and granted a security interest in certain Intellectual Property Collateral;

WHEREAS, Grantor executed and delivered a First Supplement to Intellectual Property Security Agreement dated October 7, 2013 and recorded on October 23, 2013 at Reel 031485, Frame 0013 (the “*First Supplement*”, and together with the IP Agreement, collectively the “*Grant*”) in favor of the Bank, pursuant to which the Grantor pledged, assigned and granted a security interest in certain Intellectual Property Collateral; and

WHEREAS, the Grantor has developed additional patents and patent applications (“*Patents*”) and additional trademarks and trademark applications (“*Trademarks*”), and desires to hereby confirm the pledge of, and the grant of a security interest in, such additional Patents and Trademarks in favor of Bank.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the IP Agreement.
2. Supplement to Exhibit B. Exhibit B to the IP Agreement is hereby supplemented, but not replaced, by Exhibit B-2 annexed hereto.
3. Supplement to Exhibit C. Exhibit C to the IP Agreement is hereby supplemented, but not replaced, by Exhibit C-2 annexed hereto.
4. Miscellaneous:
 - a. Except as provided herein, all terms and conditions of the IP Agreement remain in full force and effect. The Grantor hereby ratifies, confirms and reaffirms all of the representations, warranties and covenants contained therein.
 - b. This Supplement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.
