**FIRST AMENDMENT  
TO  
ASSET PURCHASE AGREEMENT**

By and between Bright Solutions International LLC ("Seller"), an Illinois limited liability company, having a principal place of business located at 2501 West Fulton Street, Chicago, Illinois 60612, and Stride Tool, LLC ("Buyer"), a Delaware limited liability company, having a principal place of business located at 30333 Emerald Valley Parkway, Glenwillow, Ohio 44139.

**RECITALS**

WHEREAS, Seller and Buyer entered into an Asset Purchase Agreement dated as of December 16, 2016 (the "Agreement");

WHEREAS, Seller and Buyer have determined that certain trademark rights were inadvertently not included in the Agreement; and

WHEREAS, Seller and Buyer wish to amend the Agreement to include the trademark rights.

NOW, THEREFORE, in view of the foregoing, Buyer and Seller agree to amend the Agreement, effective as of December 16, 2016, as follows:

1. Purchase and Sale of Assets: In Section 1.1 of the Agreement delete paragraph (c) in its entirety and substitute the following:

“(c) the patents set forth on Schedule 1.1(c) (the “**Patents**”), and the trademarks, domain names and other intellectual property rights set forth on Schedule 1.1(c) (together with the Patents, the “**IP Rights**”);”

2. Schedule 1.1(c): In Schedule 1.1(c) of the Agreement, before the heading “**Domain:**”, insert the following:


