**AMENDMENT TO THE INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT AND TS
ASSIGNMENT AGREEMENT SHORT-FORM ASSIGNMENT**

2. Amendment to Schedule A to the TS Assignment Agreement Short-Form Assignment. Schedule A is hereby deleted in its entirety and replaced with the new Schedule A dated March 16, 2017, attached hereto and incorporated herein by reference.
3. No Further Changes. This Amendment addresses only the Parties' agreement with respect to the Exhibit A of the Intellectual Property Assignment Agreement and Schedule A of the TS Assignment Agreement Short-Form Assignment. The terms and conditions of the Assignment Agreements will remain unchanged.
