


1. The Assignor transfers, assigns, and conveys to Assignee, the entire right, title, and interest in and to the Trademark, along with all goodwill associated therewith.

3. This Agreement constitutes the entire agreement between the parties and supersedes any prior understandings, agreements, or representations by or between the parties, written or oral, to the extent they relate in any way to the subject matter of this Agreement.
4. Any term or provision of this Agreement that is invalid or unenforceable in any situation in any jurisdiction shall not affect the validity or enforceability of the remaining terms and provisions of this Agreement.
