FIRST: The undersigned is an authorized person of QC Acquisitions LLC, a Delaware limited liability company (the "LLC").

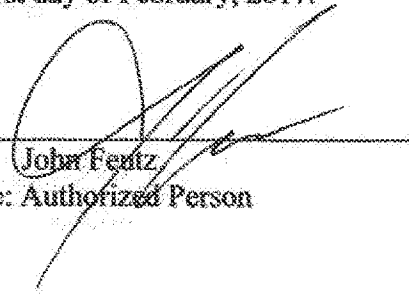
SECOND: The date of filing of the LLC's original Certificate of Formation with the Secretary of State of Delaware was October 4, 2016.
