RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made this 31 day of March, 2017, by BANK OF AMERICA, N.A., as lender ("Lender").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby (i) terminates the IP Security Agreement, (ii) releases any and all liens on, and its security interest in and to the Collateral arising under the IP Security Agreement, including, but not limited to, the Patents and Trademarks set forth on Schedule I attached hereto, and (iii) authorizes the recordation of this Release by Grantor or its designee with the United States Patent and Trademark Office.

This Release shall be governed by and construed in accordance with the laws of the State of Texas without regard to conflicts of law principles.


