**INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT**

This Intellectual Property Assignment Agreement (“Assignment”), dated as of March 3, 2017, is by and among **Valeant Pharmaceuticals International, Inc.**, a company registered under the laws of British Columbia, **Coria Laboratories, Ltd.**, a Delaware corporation, **Valeant Pharmaceuticals North America, LLC**, a Delaware limited liability company, **Valeant Pharmaceuticals Luxembourg S.A.R.L.**, a Luxembourg société à responsabilité limitée, (each, “Assignor”, and collectively, “Assignors”), and **L’Oréal USA, Inc.**, a Delaware corporation (“Assignee”).

WHEREAS, this Assignment is made and entered into in connection with the Closing of the transactions contemplated by that certain Asset Purchase Agreement, dated as of January 10, 2017, by and between Valeant Pharmaceuticals International, Inc. and Assignee (as amended or supplemented from time to time, the “Purchase Agreement”);

WHEREAS, capitalized terms used but not defined herein shall have the respective meanings given to such terms in the Purchase Agreement;

WHEREAS, pursuant to the Purchase Agreement, Valeant Pharmaceuticals International, Inc. and certain of its Affiliates agreed to sell, and Assignee agreed to purchase, the Purchased Assets, including the registered Marks, pending applications for registration of Marks, and domain names set forth on Exhibit A (collectively, the “Assigned IP”); and

WHEREAS, the execution and delivery of this Assignment is contemplated by Section 8.1(j) of the Purchase Agreement.

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignors and Assignee agree as follows:

1. Assignment. Each Assignor hereby sells, conveys, assigns and transfers to Assignee its entire worldwide right, title and interest in and to the Assigned IP, together with any and all goodwill connected with and symbolized by the Assigned IP, the same to be held and enjoyed by Assignee for its own use and enjoyment and the use and enjoyment of its successors, assigns and other legal representatives as fully and entirely as the same would have been held and enjoyed by such Assignor if this assignment and sale had not been made, as assignee of its respective entire right, title and interest therein, including all rights in and to all income, royalties, damages and payments now or hereafter due or payable with respect thereto, all causes of action (whether in law or in equity) with respect thereto, and the right to sue, counterclaim, and recover for past, present and future infringement of the rights assigned or to be assigned under this Assignment.
2. Filing and Recordation. The parties hereto agree that Assignee shall, at its sole cost and expense, promptly file and record this Assignment, or the equivalent of this Assignment to the extent required under foreign law, with the United States Patent and Trademark Office and respective foreign Trademark Offices as necessary to record Assignee as the assignee and owner of the Assigned IP.

3. Domain Name Transfer. The parties hereto agree that Assignors, at Assignee's sole expense, will perform all affirmative acts which may be reasonably necessary or desirable to implement and perfect the above-described transfer of rights and to secure transfer of the registrations of domain names listed on Exhibit A before the registrars of same as well as to cooperate with Assignee in obtaining and/or providing information required in any proceedings relating to the domain names, and Assignors hereby agree to follow Assignee's reasonable instructions in order to effectuate the transfer of the domain name registrations in a timely manner. Specifically, but without limiting the generality of the immediately preceding sentence, Assignors agree to prepare and transmit the necessary Registrant Name Change Agreements (RNCA's) or other written authorizations and/or instructions and/or to correspond with the applicable registrars to instruct and authorize transfer of the domain names, including by providing to Assignee a functioning user name and password, where available, or issuing corresponding transfer codes, sufficient for Assignee to immediately begin to administer the domain names, as well as to cooperate with Assignee in obtaining and/or providing information required in any proceedings relating to the domain names.
4. Successors. This Assignment shall inure to the benefit of and is binding upon the respective successors and assigns of Assignors and Assignee.
5. Governing Law. This Assignment shall be governed by and construed in accordance with the laws of the State of Delaware without giving effect to the conflict of laws rules thereof.
6. Counterparts. This Assignment may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original but all of which together shall constitute one and the same instrument. Delivery of an executed counterpart of a signature page of this Assignment by facsimile or by PDF file (portable document format file) shall be as effective as delivery of a manually executed counterpart of this Assignment.




