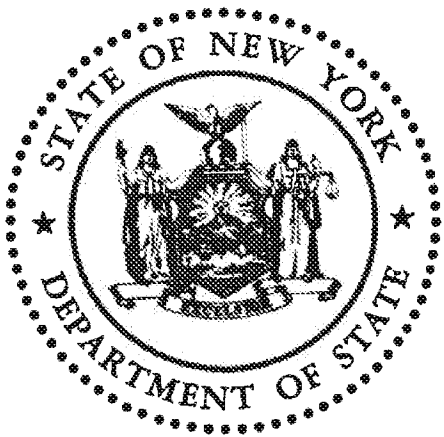

RESTATED CERTIFICATE OF INCORPORATION

OF

SHOREGROUP, INC.

Under Section 807 of the Business Corporation Law

November 8, 2016

The undersigned, being the Vice President of ShoreGroup, Inc., a New York corporation (the "Corporation"), whose Certificate of Incorporation of the Corporation (as amended, the "Certificate of Incorporation") is hereby being restated under the Business Corporation Law, hereby certifies that:

FIRST: The name of the Corporation is ShoreGroup, Inc., and the name under which it was incorporated in the State of New York was The Shoreline Group, Inc.

SECOND: The Certificate of Incorporation was filed by the New York Department of State on September 14, 2000.

THIRD: The text of the Certificate of Incorporation is hereby amended or changed to effect one or more of the amendments or changes authorized by Section 807 of the Business Corporation Law, and the amendments effected by this Restated Certificate of Incorporation of the Corporation are as follows:

Paragraph **FIRST** of the Certificate of Incorporation relating to the Corporation's name is hereby amended to read as follows:

FIRST: The name of the corporation (the "Corporation") is Optanix, Inc.

FOURTH: The restatement of the Certificate of Incorporation was authorized by the unanimous written consent of the Board of Directors of the Corporation followed by the written consent of the sole shareholder of the Corporation.

FIFTH: The text of the Certificate of Incorporation is hereby restated as amended to read in its entirety as follows:

CERTIFICATE OF INCORPORATION

OF

OPTANIX, INC.

Under Section 402 of the Business Corporation Law

The undersigned hereby certifies that:

FIRST: The name of the corporation (the "Corporation") is Optanix, Inc.

SECOND: The purpose of the Corporation is to engage in any lawful act or activity for which a corporation may be organized under the Business Corporation Law. The Corporation is not formed to engage in any act or activity requiring the consent or approval of any state official, department, board, agency or other body without such consent or approval first being obtained.

THIRD: The county, within this state, in which the office of the Corporation is to be located is: New York County, New York.

FOURTH: The Corporation shall have authority to issue one class of shares consisting of one thousand (1,000) Common Shares, par value \$0.01 per share.

FIFTH: The Secretary of State is designated as agent of the Corporation upon whom process against the Corporation may be served. The address within the State of New York to which the Secretary of State shall mail a copy of any process accepted on behalf of the Corporation is: c/o Corporation Service Company, 80 State Street, Albany, New York 12207-2543.

SIXTH: The Board of Directors of the Corporation is expressly authorized to make, alter or repeal the By-laws of the Corporation.

SEVENTH: The Corporation shall, to the fullest extent permitted by Article 7 of the Business Corporation Law, as the same may be amended and supplemented, indemnify any and all persons whom it shall have power to indemnify under said Article from and against any and all of the expenses, liabilities, or other matters referred to in or covered by said Article, and the indemnification provided for herein shall not be deemed exclusive of any other rights to which any person may be entitled under any By-Law, resolution of shareholders, resolution of directors, agreement, or otherwise, as permitted by said Article, as to action in any capacity in which he served at the request of the Corporation.

EIGHTH: The personal liability of the directors of the Corporation is eliminated to the fullest extent permitted by the provisions of paragraph (b) of Section 402 of the Business Corporation Law, as the same may be amended and supplemented.
