The undersigned, Barry Watkins, Co-Chairman and Michael Bair, Secretary, respectively of Madison Square Garden Cheering for Children Foundation (the "Corporation"), do hereby certify that:

(1) The name of the Corporation is "Madison Square Garden Cheering for Children Foundation."

(2) The certificate of incorporation of the Corporation was filed by the Department of State on the 4th day of December, 1997. The Corporation was formed under the Not-for-Profit Corporation Law of the State of New York.

(3) The Corporation is a corporation as defined in subparagraph (a)(5) of section 102 of the Not-for-Profit Corporation Law and is a Type B corporation under section 201 of said law. The Corporation shall hereafter be and remain a Type B corporation under section 201 of the Not-for-Profit Corporation Law.

(4) Paragraph FIRST of the certificate of incorporation of the Corporation, which sets forth the name of the Corporation is hereby amended to read as follows:


FIRST: The name of the Corporation is: "Garden of Dreams Foundation."

(5) This amendment to the certificate of incorporation of the Corporation was authorized by the unanimous written consent of the sole corporate member of the Corporation,


(6) Prior to delivery to the Department of State for filing, all approvals or consents required by law, will have been endorsed upon or annexed to this certificate of amendment.
