TRADEMARK ASSIGNMENT

Assignor does hereby, assign, transfer and convey to Assignee, its successors and assigns, absolutely and forever, its entire right, title and interest, whether statutory or at common law, in and to the Mark, together with goodwill of the business symbolized by the Mark throughout the world and all registrations therefor, in the United States of America, its territories and possessions, and any foreign countries, together with all causes of action for any and all previously occurring infringements of the rights being assigned and the right to receive and retain the proceeds relating to those infringements.

2. This Assignment is binding upon, will inure to the benefit of and shall be enforceable by each of the parties hereto and their respective successors and assigns and may be executed in two or more counterparts (including by means of facsimile and/or electronic transmission), each of which will be deemed an original but all of which together constitute but one and the same instrument.

3. Assignor and Assignee may amend, modify and supplement this Assignment in such manner as may be mutually agreed by them in writing.
